Subject: Extension of the validity of FCRA registration certificates

In continuation of Ministry of Home Affairs' Public Notice No. II/21022/23(22)/2020-FCRA-III, Dated 25.09.2023, the Central Government, in public interest, has decided to extend the validity of FCRA registration certificates of the following categories of FCRA registered entities:

- (i) The validity of registration certificates of such entities whose validity was extended till 31.03.2024 in terms of the Public Notice dated 25.09.2023 and whose renewal application is pending, will stand extended till 30.06.2024 or till the date of disposal of renewal application, whichever is earlier.
- (ii) The validity of those FCRA entities whose 5 years validity period is expiring during 01.04.2024 to 30.06.2024 and who have applied/will apply for renewal before expiry of 5 years validity period, will stand extended upto 30.06.2024 or till the date of disposal of renewal application, whichever is earlier.
- 2. All FCRA registered associations are therefore advised to take note that in case of refusal of the application for renewal of certificate of registration, the validity of the certificate shall be deemed to have expired on the date of refusal of the application of renewal and the association shall not be eligible either to receive the foreign contribution or utilise the foreign contribution received.
- 3. This issues with the approval of the Competent Authority. All concerned may take note of the above decision and take appropriate action in the matter.
