Sub : Processing Charges for issue of Blood/Blood Components to the patients admitted in Private Hospitals /Autonomous Bodies/ Nursing Homes/ Private Ward of Government Hospitals/ Private Ward of Government Blood Banks and Processing Charges from Government Hospitals-Reg.

The Managing Body of the Indian Red Cross Society in its meetings held on 25.08.2016 & 28.03.2017 has decided to revise the rate of existing processing charges from patients admitted in Private Hospitals/ Autonomous Bodies/ Nursing Homes/ Private Ward of Government Hospitals and patients admitted in the Government Hospitals. Revised rates are as under :

1. Rates for the patients admitted in Private Hospitals /Autonomous Bodies /Nursing Homes.

(i)	Packed Red Cells/ Whole Blood	Rs.1,450/- per unit
(ii)	Fresh Frozen Plasma	Rs.400/- per unit
(iii)	Platelet concentrate	Rs.400/- per unit
(iv)	Cryoprecipitate	Rs.250/- per unit

2. Rates for patients admitted in Government Hospitals.

(i)	Packed Red Cells/ Whole Blood	Rs.1,050/- per unit
(ii)	Fresh Frozen Plasma	Rs.300/- per unit
(iii)	Platelet concentrate	Rs.300/- per unit
(iv)	Cryoprecipitate	Rs.200/- per unit

3. Rates for any specialized requirement/test/procedure have also been fixed as follows :-

1	NAT Screening	:	Rs. 900/- per unit for whole blood/Red Cells
2	Antibody screening (donor & patient) by 3 Cell panel	:	Rs. 300/-
3	IV Generation ELISA (HIV) Hep. B & C	:	Rs.200/-
4	Leucofiltered by integral filter / pre- storage filter	:	Rs.1000/-
5	Leucofiltration Platelets	:	Rs.1000/-
6	Leucofiltration using quadruple bag	:	Rs. 150/-
7	Grouping and cross matching by automation	:	Rs.150/-
8	Grouping and cross matching by semi- automation	:	Rs.120/-
9	Ph Phenotyping for extended serology	:	Rs. 500/-

In addition to above, it has also been decided that following category of patients are exempted from payment of service charge :-

- (a) Thalassemic, Hemophilia patients, Sickle Cell Anaemia patients and any other blood dyscrasia and HIV/AIDS patients requiring repeated blood transfusion.
- (b) Patients holding National Food Security Card (EWS/BPL) for families /individuals
- (c) Rama Krishna Mission, Hardwar & Vrindavan Hospital.

Further, the following have also been decided :-

- (i) 50% tested blood be issued without service charges for the stock of Government Hospitals who support IRCS, Blood Bank in conducting the Blood Donation Camps where the manpower and consumables have been mutually shared by them.
- (ii) No security deposit will be collected henceforth in lieu of replacement donation.

This order comes into force with immediate effect.
