Background

There is, however, a shortage of facilities like old age homes and healthcare facilities that provide affordable and reliable socio-medico care. In this scenario, trained Home Health Aides (HHAs) offer a solution that can be customized and offered at the home of those who need.

The Ministry of Skill Development and Entrepreneurship, Government of India, has partnered with IRCS (NHQ) to run a programme for training Home Healthcare Aides. The programme, which will bridge the demand and supply gap for home-based care is set to start soon.

IRCS is looking for health-care professional who are inspired and equipped to train participants to become Home Healthcare Aides who will provide the much-needed care and support to elderly or those in need.

Qualified professionals who have retired, including nursing staff, are also strongly encouraged to apply.

Key responsibilities include:

- Supervising students during laboratory and clinical work

- Assessing clinical education needs of patients and clients
- Advising students on academic and vocational curricula and providing career guidance
- Maintaining student attendance record, grade and other required record
- Supervising students during their internship



- Participating in student registration process
- Selecting and requesting materials and supplies such as textbooks and laboratory equipment
- Collaborating with other colleagues to address teaching and research issues
- Any other responsibility assigned by the supervisor
- To impart soft communication skills
