It is my privilege and honor to welcome all of you and to express the deep appreciation of the Indian Red Cross Society to the Hon'ble President for agreeing to preside over the Ceremonial Session of the Annual General Meeting and to give away the prizes to best performing branches & distinguished Red Crossers.

Madam, your generous offer to host the AGM, including the Business Session, in Rashtrapati Bhavan, indeed shows your support and interest in the humanitarian work of Indian Red Cross.

I would also like to extend a hearty welcome to our Hon'ble Chairman and thank him for his visionary guidance and leadership.

Today I feel proud to say that Indian Red Cross has lived up to its commitment and contributed to the betterment of the society. Let me use this opportunity to share some of the activities and initiatives of Indian Red Cross Society.

Disaster response continues to be one of the core activities. Indian Red Cross Society have responded to all kinds of emergencies, including cyclones and floods, by releasing relief items, assisting the authorities to evacuate people at-risk, setting up of relief camps and by providing food, water & medical aid.

As we all know, COVID-19 pandemic presented unprecedented challenges and IRCS quickly adapted its ongoing programs to respond to the situation. With over 50,000 volunteers, IRCS worked round the clock to ensure an uninterrupted supply of blood services. The branches distributed medicines, food, ran quarantine and isolation

centers, vaccinated people and helped in conducting covid tests. IRCS was also designated by the Govt. of India as the sole consignee of all the foreign aid received in kind from abroad.

With the support of our international partners, IRCS has been able to provide 69 ambulances, 59 blood collection vans and 39 mobile health units and testing vans to various Red Cross branches in 27 states and UTs. With these, more than 160 additional vehicles, the field branches are now better equipped to serve the needs of their communities.

IRCS is running more than hundred blood centres and organizing blood collection camps in different parts of the country. During the year 21-22, Blood Centre at the National Headquarters provided around 16000 units of blood & its components, free of cost, to the patients admitted in Government Hospitals, Thalassemic and Hemophilics.

As one of its major initiatives, National Headquarters has started online examination of First Aid, on pilot basis in Delhi, Haryana and Punjab. So far over 25,000 candidates have been registered and more than 20,000 certificates have already been issued, which have been downloaded by the successful candidates. After the system is validated during pilot phase, it will be rolled out in the entire country, which will streamline the entire process.

IRCS has signed MoUs with 26 Universities in few states including Punjab, Himachal Pradesh & Rajasthan, so that the students at these Universities learn, among other things, humanitarian principles.

Indian Red Cross Society has covered around three thousand patients in different states with adherence rate of above 95% for prevention of multiple drug resistance of TB patients.

Madam, we are ensuring transparency and accountability in the National Headquarters and also placing details of our income & expenditure in public domain. We have also adopted technology and digitization for the efficient functioning of IRCS.

I would conclude by saying that Indian Red Cross with a network of more than 1100 branches continues to provide a wide range of services and programs across the country, for which I thank all the members, volunteers, staff and stake holders of Indian Red Cross.

With these words, I once again welcome all of you.

## Address by Hon'ble President of India and Hon'ble President of Indian Red Cross Society, Smt. Droupadi Murmu

I'm delighted to be here with all of you volunteers and delegates from all regions of the country. I want to extend my sincere congratulations to all the awardees and Red Cross employees who received awards today.

Today, three branches of the Red Cross from Odisha, Jammu-Kashmir and Haryana have been awarded. Along with this, Dr. Ambati Nataraj and Dr. Goparaju Samram have also been honored today. All the awardees have demonstrated excellent examples of how individuals and institutions may support the selfless cause of blood donation.

This year, in April, I visited my village in Odisha. I saw young children carrying the Red Cross emblem when I reached there. The Red Cross emblem was being carried by young children who were standing nearby. Through such initiatives, kids also learn the value of blood donation and develop a sense of altruism. In Indian tradition,

altruism has been regarded as one of the most significant human values. Our ancient literature contains instances of organ donation for the good of the entire civilization.

In our culture, service to the people is the service to God (Nar Seva Narayan Seva). Today's award winners embody such values of welfare of humanity embedded in Indian culture. I hope that others will get inspiration from their work.

For more than a century the Indian Red Cross Society has provided humanitarian aid. The Red Cross has proven its dedication via relief efforts in the wake of natural catastrophes and medical emergencies.

You all know that an appropriate and sufficient amount of blood is required at the time of any accident or crisis. I am told that the Indian Red Cross Society, through more than one hundred blood donation centres and mobile campaigns across the country, is meeting about 10 percent of India's blood-related needs to save lives. By collecting blood safely for those in need, you all are playing an excellent role and helping to promote the culture of voluntary blood donation. I appreciate your efforts in organizing blood donation drive, creating awareness and ensuring safe and adequate blood supply across the country.

Even today, in the minds of some people, there are many apprehensions regarding blood donation. To encourage people for this great social cause, it is necessary to clear the apprehensions and misconceptions about blood donation. I want you to dispel the myths around blood donation and engage everyone, especially youth.

The COVID-19 pandemic has been exceptionally challenging for the country and the world at large. During this crisis, the Indian Red Cross Society rendered important services. This organisation assisted in distributing accurate information and mobilising resources to assist individuals afflicted by the pandemic. People linked with this organisation assisted the district administration in raising awareness and providing help without caring for their own lives. Covid-warriors in the country included members of the Indian Red Cross Society.

India has created a world record by giving more than 220 crore vaccine doses in a short span of time to combat the COVID-19 pandemic. But it is important for us to always be ready to face the challenges of the future. It is very important that we adopt innovation and adapt ourselves according to the changing circumstances. Revolutionary changes can be brought in humanitarian aid with the help of technology. Red Cross Society can also use the potential of digital technologies to

expand its reach.

Lastly, I would like to appreciate all the members and volunteers of Indian Red Cross Society for their dedication and service towards humanity. Your dedication, compassion and selfless spirit towards human service inspires all countrymen.

I hope you will continue to work for the cause of humanity's welfare. My best wishes to all of you for your bright future and congratulate all of you.

The General Body assembled for the Business Session in the Rashtrapati Bhavan, New Delhi on 17<sup>th</sup> July 2023 from 12.00- 1.00 PM. The Business Session was chaired by Dr. Mansukh Mandaviya, Hon'ble Chairman of IRCS and Minister for Health and Family Welfare and Chemicals & Fertilizers, Gol.

Members of the Managing Body of the Indian Red Cross Society, delegates, observers, awardees were present in the Business Session.

Sh. R.K Jain, the Secretary General once again welcomed the Hon'ble HFM and Hon'ble Governors present on the dais along with all the other delegates, observers and awardees for attending the Business Session. He thanked the Hon'ble President for kindly hosting the Ceremonial Session at Rashtrapati Bhavan auditorium which added ostentation to the meeting.

With the permission of the Hon'ble Chairman, Sh.R.K.Jain, Secretary General presented the following agenda for consideration and adoption by the General Body.

- 1. Confirmation of the proceedings of the last Annual General Meeting held on 17<sup>th</sup> May, 2022.
- 2. Presentation, consideration and adoption of;
  - i. Annual Report and Audited Annual Accounts for IRCS for the year 2021-22.
  - ii. Annual Budget Estimates of Income and Expenditure for the year 2023-24.
  - iii. Approval for the appointment of the Statutory Auditors for the year 2023-24.

#### **Statutory Agenda**

First item was confirmation of the proceedings of the Annual General Meeting of IRCS held on 17<sup>th</sup> May, 2022.

#### **Confirmation of Proceedings**

The Secretary General IRCS announced; "We have circulated the proceedings of the last AGM held on 17<sup>th</sup> May 2022, electronically. The printed copies have also been provided to the branches as well as these are published on our website, but no comments have been received from anyone. As a result, we accept it as confirmed." Attendees confirmed the proceedings by nodding and waving their hands.

#### **Adoption of Annual Reports**

The Secretary General announced that the second agenda item is the adoption of the Indian Red Cross Society's Annual Report for the year 2021-2022. Secretary General said, "These Annual Reports were already circulated to branches electronically. The National Managing Body approved it in a meeting attended by all members of the Managing Body. So, if there are no comments, we can move forward with this. We will also post it on our website. The delegates waved their hands affirming their consent. Accordingly, the report was adopted.

#### **Adoption of Annual Accounts**

The Secretary General announced that the adoption of the Indian Red Cross Society's Audited Annual Accounts for fiscal year 2021-22 would be the next item on the agenda. The audited annual accounts, he said, had been approved by the Indian Red Cross-National Managing Body and had been circulated. Because there are no comments, we can adopt the Annual Accounts too. With the consent of the delegates the Annual Accounts for the year 2021-22 were adopted.

#### **Adoption of Annual Budget**

Following the reports & accounts for the year 2021-22, the annual budget estimates for the year 2023-24 were presented. The Secretary General stated, "The Annual Budget Estimates of Income and Expenditure of the IRCS for the year 2023-24 have been approved by the Finance Committee and the Managing Body and these have also been circulated." Accordingly, the General Body adopted the Annual Budget.

#### **Appointment of Statutory Auditors**

Appointment of Statutory Auditors for fiscal year 2023-24 was the next item on the agenda. The Secretary General informed that the Finance Committee of Managing Body had approved and has recommended the appointment of M/s A. J. Mohan & Associates as IRCS Statutory Auditors for two FY i.e 2020-21 & 2021-22. This firm has agreed to undertake audit at a nominal fee of Rs. 24,000 per annum, which is less than half of the amount we have been paying in the past. He added that it was decided in the last AGM held in May 2022 that a CA firm should be appointed as a Statutory Auditor for maximum period of 3 years. IRCS requested this firm and they have consented to do annual audit for one more year i.e for FY 23-24 at the same cost of Rs 24000 including GST. He also informed that the appointment of M/s A. J.

Mohan & Associates as Statutory Auditor of IRCS for the year 23-24 has also been approved by the Hon'ble Chairman. Then Secretary General requested the General Body of IRCS to kindly approve the appointment of M/s A. J. Mohan & Associates as the Statutory Auditors of IRCS NHQ for the FY 2023-24. The General Body approved the proposal.

After the consideration and adoption of the agenda items the Hon'ble Chairman Dr. Mansukh Mandaviya was requested to kindly present the "Certificates of Merit" to the volunteers and members of the Indian Red Cross Society for the year 2021-2022.

#### **Presentation of Certificate of Merit**

The Rules for award of certificate of merit was announced as below; -

"As per rules, there is provision for the distribution of certificates of merit to distinguished Red Crossers who have served Red Cross for a minimum of 10 years. Certificates of merit are given to a maximum of six people in one year". It was announced that the National Headquarters' Awards Committee have recommended the certificates of merit to six eminent Red Crossers from various branches, which have been approved by the Hon'ble Chairman.

#### Governor of Bihar, Sh. Rajendra Arlekar:

Welcome, everyone, to this meeting!

Commendable work is being done by all of us. Representatives from different states, who have done good work, and also those who have done less work, would carry positive energy from here. Each of us has participated in blood donation programs and medical camps organised by our State Branches.

I have a small suggestion. Whenever we have medical camps, they shouldn't just be for allopathy; we should also organise Ayurveda camps because this is also a form of medicine, one that we have cherished for centuries, and this also needs to be propagated.

#### Governor of Jharkhand, Sh. C. P. Radhakrishnan:

Red Cross is the largest voluntary organisation serving humanity in the world. My Jharkhand state branch needs to step up its efforts. We want more and more district branches to actively participate in different activities.

Encouragement of blood donation programme is necessary. People also need to be made aware of the importance of organ donation. Malnutrition also must be eliminated, so we are experimenting with the distribution of protein rich food items to the needy and vulnerable.

In Jharkhand, we are working to eradicate tuberculosis. Our Red Cross has to be strengthened so that it can serve the society better through its volunteers. Thank you.

#### Governor of Telangana, Dr. Tamilisai Soundararajan:

As the Governor of Telangana, I would like to highlight a couple of things. As a physician myself, I understand the significant impact that the cost of medications can have on patients, often hindering their ability to complete the full course of treatment.

Additionally, Telangana Red Cross has initiated a program called the CPR Challenge, focusing on cardiopulmonary resuscitation (CPR) training. It is imperative that every member receives training in CPR. Additionally, we are actively promoting the practice of first aid and blood donation across the state. It is crucial to inspire both Junior Red Cross (JRC) and Youth Red Cross (YRC) members to volunteer for humanitarian causes, fostering a culture of service and compassion amongst the youth.

I urge the organization for hosting conferences at the national, state, and district levels. These would serve as platforms for discussion, collaboration, and planning regarding the expansion of Red Cross membership to colleges and enhance the reach and impact of the Red Cross.

Developing an app in multiple languages can serve as a powerful tool for inspiring younger generations and raising awareness about Red Cross initiatives.

I express my gratitude for the ambulances and other medical vehicles provided by our National Red Cross Headquarters. While serving tribal villages, we encountered challenges with accessibility to hospitals through ambulances. As a solution, we acquired 2-Wheeler ambulances, which proved to be invaluable in reaching remote areas. Considering that states like Telangana have a significant tribal population, I believe it would greatly benefit such regions if the Red Cross NHQ could supplement our 2-Wheeler ambulances/fleet.
